#### **COURSE DESCRIPTION**

**TTPT 703 - Church & Society:** This course focuses on A study of biblical ethics and the role the local church plays in the community. Special attention will be given to major social problems such as sanctity of life, chemical abuse, domestic violence, social ills, and the political process. **Note(s):** Required of M.A.C.M.L. (Pastoral Care and Counseling), M.A. Diversified, and M.Div. (except Missions and Intercultural Studies) students.

#### **COURSE ALIGNMENT WITH PROGRAM LEARNING OUTCOMES**

TTPT 703 - Church & Society: This masters course is a core course required of all M.A.C.M.L. (Pastoral Care and Counseling), M.A. Diversified, and M.Div. majors designed to be taken at any time during the program. Successful completion of this course (see next section) will prepare students to demonstrate a developing proficiency toward the accomplishment of the following Program Learning Outcomes:

Demonstrate a commitment to and ability to develop redemptive church ministries to their communities in society and culture, being relevant to current sociopolitical issues and ethical problems (MACML #5), Counsel pastorally. Students will learn basic relationship skills, counseling skills, ethical guidelines in pastoral counseling, and develop a plan or referring some counselees (MDiv #7), Be able to dialog with those who are outside of a biblically centered faith confidently and effectively, applying the knowledge of biblical doctrine to refute errors and to utilize practical techniques of dialog with the intent to reach those who "seek to know the reason for the hope that lies within you." (MADiversified #2)

#### COURSE OBJECTIVES AND STUDENT LEARNING OUTCOMES

By the completion of this course including class participation, class assignments (referred to as "Assignments"), class readings and group interaction, the following objectives and learning outcomes will be assessed and demonstrated:

**IDEA OBJECTIVE #3**: Learning to apply course material to improve thinking, problem solving, and decisions with regard to ethical dilemmas faced in pastoral ministry. (Essential emphasis).

**Student Learning Outcomes** (The learner will demonstrate that he or she has satisfactorily fulfilled IDEA Objective #3 by being able to):

- > **Articulate** the biblical parameters for the primary moral issues faced in pastoral ministry. Fulfilled by Assignment #1 and 2.
- > *Identify* the specific pastoral dimension of the primary moral issues faced in pastoral ministry. Fulfilled by Assignments #1 and 2.
- > **Defend** a biblically consistent position on each of the primary moral issues faced in pastoral ministry. Fulfilled by Assignments #1 and 2.

**IDEA OBJECTIVE #10**: Developing a clearer understanding of and commitment to, biblical ethics. (Essential emphasis).

**Student Learning Outcomes** (The learner will demonstrate that he or she has satisfactorily fulfilled IDEA Objective #10 by being able to):

- > **Describe** the principal components of Christian ethics. Fulfilled by Assignment #1.
- > Give examples of the variety of ways in which people in the culture think about right and wrong. Fulfilled by Assignment #1.
- > **Demonstrate** an understanding of vocation that affirms the ministry of the workplace. Fulfilled by Assignment #1 and 2.

**IDEA OBJECTIVE** #11: Learning to analyze and critically evaluate ideas, arguments, and points of view with regard to primary moral issues faced in the pastoral ministry. (Essential emphasis).

**Student Learning Outcomes** (The learner will demonstrate that he or she has satisfactorily fulfilled IDEA Objective #11 by being able to):

- > **Distinguish** between moral positions that are consistent with biblical parameters and those that are not. Fulfilled by Assignment # 1 and 2.
- > **Critique** positions on moral issues that are at variance with above biblical parameters. Fulfilled by Assignment #1 and 2.
- > **Recognize** points of vulnerability in the rationale being defended on moral issues. Fulfilled by Assignment #1 and 2

#### **COURSE OUTLINE**

#### **Course Format:**

Conducted online over 8 weeks in June and July, 2014. Students will interact with the instructor and each other through daily interactive on-campus and online discussions and other assignments. The class will meet in the classroom on two Saturdays from 9 am-1pm (6/28, 7/26). The remainder of the class will be conducted online. Since this is a summer course, it moves very quickly.

Each week will consist of reading, video lectures, and discussion questions for interaction on Canvas learning management system.

#### **Assignments:**

- 1. Reading of all texts, viewing of all video segments and in class/on line class discussion (counts 25% of your grade). All reading except for Kilner is due on the day it is assigned. The Kilner reading is not due until July 27. All discussion posts are due on the Sunday of the week that they are assigned.
- 2. 3 case papers addressing a case study on a specific issue in social ethics. These should be 5-6 pages in length, and each paper counts 25% of your grade. You may do any three case papers you wish. All cases, except as specifically noted, are in Rae, Moral Choices. Each case has a handful of questions to be addressed in your paper. Integrate the answers to these questions into a well constructed essay that includes an introduction and conclusion. You may include any other material that you think helps address the case. Outside resources are not required, but if used, must be documented (format for documentation is either APA or Chicago style, your choice). Each case is placed in the module in which it occurs. Case papers are due on the week of that topic's discussion.
